ince 1936, Nishnabotna Valley Rural Electric Cooperative has been working to deliver reliable and affordable power to our member-owners. It's a mission at the heart of everything we do. As we entered our 86th year in 2022, we continued that commitment despite significant challenges.

From inflationary pressures that saw everything from poles and wire to transformers and trucks skyrocket in price, to combating the increasing instability in the wholesale power market, last year served as a reminder of how well-suited the cooperative business model is for difficult times.

By working together, we've been able to largely overcome these challenges. However, as we look into the future, we recognize there will be tough days ahead. A rapid transition to renewable energy sources, such as wind and solar power, coupled with an increase in demand is making the electric grid cleaner, but less reliable.

As we've shifted away from traditional baseload resources like coal and nuclear generation, power supply has become increasingly intermittent and frequently stretched. With the antici-





pated growth of electric transportation and a nationwide call for the increased electrification of our homes and businesses, things are unlikely to improve in the short term.

Thankfully, Nishnabotna Valley REC is working to identify creative solutions to help our members save money and reduce our wholesale power costs. These include exploring new rate structures that more closely mirror how the co-op is charged for the power our members consume, and innovative programs like the Switch Makes Cents load management program and other technologies that enable members to save money while enjoying the comfort and convenience they deserve.

We thank you, our member-owners, for the trust you place in us. As we reflect on the successes and challenges of the past year, we remain committed to our members and the communities we serve. Unlike traditional investor-owned utilities, we're driven by our members on Main Street, not shareholders on Wall Street. That

means every decision we make is done with your best interest in mind. It also means your participation is key in helping to guide your cooperative.

By **Powering Forward Together**, we're confident Nishnabotna Valley REC and our members have a bright future ahead.

We hope you'll attend and enjoy this year's member appreciation event which is held on Thursday, August 24, from 5 - 7 p.m. at Veteran's Memorial Auditorium in Harlan.

LEADERSHIP REPORT

RELIABILITY

As we wrapped up our multi-year work plan in 2022, Nishnabotna Valley REC continued to make significant investments – over \$3.2 million – to strengthen our electric distribution system. Last year, Nishnabotna Valley REC constructed five miles of underground and overhead line, replacing aging equipment to help ensure reliable service.

Members on average saw just 0.85 outages throughout 2022, lasting approximately 95 minutes according to the Annual Reliability Report NVREC provides the Iowa Utility Board each year.

THE COOPERATIVE ADVANTAGE

Belonging to an electric cooperative has many advantages. Unlike an investor-owned utility that distributes profits to shareholders in the form of dividends, when Nishnabotna Valley REC's revenue exceeds our expenses, we return that money to you, our member-owners, in the form of patronage capital.

In 2022, Nishnabotna Valley REC's board of directors authorized the return of more than \$329,000 to our members who belonged to the cooperative in 2001 and 2021.

PREPARING FOR ELECTRIC VEHICLES

To prepare for the potential widespread adoption of electric vehicles in our service area, Nishnabotna Valley REC formed an electric vehicle (EV) task force in 2022. Charged with exploring the opportunities and challenges posed by EVs, the group analyzed current and projected load data, crafting a detailed report and corresponding recommendations.

By proactively preparing, Nishnabotna Valley REC and our members will be better positioned for future growth.

SAFETY

Nishnabotna Valley REC remains dedicated to having a culture of safety. Last year employees safely worked 43,306 hours without a lost time accident and have worked since 2020 without a lost time incident.

We are also active participants in Commitment to Zero Contacts, a nationwide safety program that helps ensure our employees return home safely each night.



SUSTAINABILITY

At Nishnabotna Valley REC, we advocate for new technologies that benefit our membership and add to quality of life. We believe in an "all-of-the-above" approach to electric generation, supporting the incorporation of new renewable energy resources alongside reliable, baseload generation.

As more renewable energy sources are added to the electric grid, electricity is becoming an increasingly clean energy source, providing local economic and environmental benefits.

TRAINING AND PROMOTIONS

In 2022, Todd Bruck and Chad Pitts attended excavation and trenching safety training. In addition, Jeremiah Ruby attended a transformer workshop.

Nishnabotna Valley REC also developed the Field Training program. This cross-training helps educate our member care specialists about our distribution system, enabling them to better serve our members.

SUPPORTING OUR COMMUNITIES

Nishnabotna Valley REC is committed to improving the communities we serve. Last year, the cooperative was proud to provide more than \$14,800 in donations to schools, scholarships, county fairs, local parishes, and community organizations.



In addition, Nishnabotna Valley REC employees spent time in November hanging Christmas lights and decorations on and around the Shelby County Courthouse square during our annual employee service day.

ECONOMIC DEVELOPMENT

Additionally, the board of directors continues to support issuing Revolving Loan Funds (RLF). The cooperative has helped businesses such as Buck Snort in Neola and Harlan, and Destination Coffee and Dairy Queen in Oakland.

Utility-sponsored RLF and USDA Rural Economic Development Loans and Grants can make a crucial difference to community infrastructure and business growth.

These programs exist to promote rural economic development and support job creation, and Nishnabotna Valley REC works hard to put that money to use to strengthen our communities.

DO YOU HAVE AN UNCLAIMED PATRONAGE CHECK?

Help reunite NVREC members with their money!

Nishnabotna Valley REC's retirement of patronage capital process has been very successful for decades, but sometimes it is difficult to find former members of NVREC who have moved away or have not left a valid forwarding address with the cooperative.

In short, when a patronage capital retirement occurs, NVREC simply cannot find these former members in order to give them the money that belongs to them.

The following is a list of names of individual members who have uncashed patronage checks older than June 30, 2019. These members, or their authorized representatives, have until September 8, 2023 to contact us so that the checks can be reissued.

If not claimed, the funds may be donated to the Nishnabotna Valley Foundation or help support the cooperative's economic development programs.























Annual Meeting minutes from August 25, 2022

The Annual Meeting of the Members of Nishnabotna Valley Rural Electric Cooperative was held at the Veteran's Memorial Auditorium in Harlan, Iowa, at 7:00 P.M. on the 25th day of August, 2022.

The meeting was called to order by Darrell Stamp, President of the Cooperative, who presided, and Bryan Greve, Secretary/Treasurer of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof.

A recording of the National Anthem was played over a loud-speaker.

The Chairman appointed Cooperative Attorney Kyle Kruidenier as the Parliamentarian for the meeting.

The Chairman welcomed the members and then introduced Tom Pattee who gave the invocation.

The Chairman introduced the Board of Directors and had them stand as he called their names.

The Chairman introduced CEO Bill McKim who welcomed the members attending in person and online via Facebook. He stated that it would be in order for the registration to be accepted in lieu of roll call unless there were objections. No objections were heard and the registration was accepted in lieu of a roll call.

CEO McKim stated that the Notice of the Annual Meeting was mailed to all of members on July 19, 2022 and that a copy can be found in the Annual Report, which is available for reference at www. nvrec.com. In lieu of reading the Notice, a motion was duly made, seconded and carried, in which reading of the Notice and proof of mailing was waived, and such Notice, proof, and Annual Report were ordered to be annexed to the minutes of this meeting.

CEO McKim offered to read the minutes of the Annual Meeting of members held on August 11, 2021. A motion was duly made, seconded and carried, to waive the reading of said minutes and they were thereupon declared to be approved and were ordered to be filed in the records of the Cooperative.

CEO McKim then made a few remarks recognizing that this year marks Nishnabotna Valley REC's 85th anniversary and introduced a video produced by REC staff highlighting the beginnings of the REC as well as some of the REC's accomplishments from the past year.

The Chairman, then introduced Attorney Kruidenier who stated that the number of members who had registered at the door had been checked, and that a quorum was present for the transaction of business. Attorney Kruidenier then stated that the next order of business was the election of two (2) directors for a term of three (3) years each. He further stated that in accordance with the Bylaws, the Board of Directors had appointed from the members of the Cooperative, a Nominating Committee consisting of Jayme Arkfeld, Larry Whitson, Alex Hansen, Keith Holtz, Michael Schleimer, Don Applegate, and Kyle Kirchhoff.

Attorney Kruidenier explained the nominating process and then presented the report of the Nominating Committee, nominating the following members for directors:

THREE-YEAR TERM

District No. 2: Galen Grabill **District No. 7:** Darrell Stamp

The Director candidates were introduced, and the Report of the Nominating Committee was ordered to be identified by the Secretary and annexed to the minutes of the meeting.

Attorney Kruidenier explained that because Galen Grabill and Darrell Stamp were each running unopposed in their respective districts that a unanimous ballot could be cast by motion.

The Chairman, then asked for and a motion was made, seconded and carried that the Secretary cast a unanimous ballot for Galen Grabill from District 2, and Darrell Stamp from District 7 to serve a three (3) year term and until their successors are elected and qualified.

Attorney Kruidenier thereupon declared such members duly elected directors of the Cooperative to hold office for the term specified, and until their successors shall have been elected and qualified.

The Chairman then congratulated Director Grabill with his re-election and thanked the members for re-electing him.

Director Donna Olson then thanked the members for their participation and informed them that the annual meeting prizes would be drawn and announced the following day.

The Chairman called for any other business to come before the meeting and there was none.

There being no further business to come before the meeting, upon motion duly made, seconded and unanimously carried, the meeting adjourned.
